We are proud to present this year's Annual Report to the public and our donors. This is the start of our sixth year serving all the students of District 300 as we help to "enhance and extend learning experiences" at the classroom level.

Since the inception of the Foundation in 2002 we have provided educational tools, learning experiences, specialized equipment in the sciences, industrial arts, and music and fine arts programs for all D300 students. We have provided 119 innovation and large grants totaling \$216, 819. This could not be possible without the generous donations we have received from our donors, foundations and corporate partners.

For the 07-08 school year the Foundation has awarded \$31,650 in large grants and \$5,271 in innovation grants. The list of those grants you will find on pages 2 and 3.

Large Project Grants



Science & Technology Van de Graaff Electrostatic Generator

The Middle Schools are now teaching electricity and static electricity. One important piece of equipment is a Van de Graaff Electrostatic Generator. This shows the transfer of electrons in a very dramatic way as it shows the formation of lightning and hail. Total: \$2,250.

DNA Fingerprinting Electrophoresis

The Foundation purchased the Electrophoresis equipment for all three high schools to do DNA fingerprinting. "This is an important technology piece that we would like to add to our curriculum. It is an important use of the scientific method and laboratory techniques that are currently used," said Maggie Jung, who serves on the Foundation Science and Technology Committee. Total: \$3,600.

Physics Timers and Momentum Cars for the Classroom

Students will be using more accurate tools to gather data. Each high school received this equipment costing \$15,000 overall.

The Literacy Committee Presents Illustrator Yuyi Morales

Ms. Yuyi Morales, illustrator of the book written by Kathleen Krull, *Harvesting Hope: The Story of Cesar Chavez*, discussed her artwork at Lakewood School, serving 780 students, on Monday, November 5th. At Hampshire High School, an assembly was held to discuss her artwork in the gym for 300 art students on November 6th.

The Book Illustration Project was made possible through a grant awarded by the District 300 Foundation for Educational Excellence to purchase classroom sets of the book *Harvesting Hope: The Story of Cesar Chavez* for both schools, illustration materials, and to arrange honorarium and travel for Ms. Morales' visit.

Computerized Kiln

The Foundation purchased a much needed new computerized kiln for Dundee Crown High School this year. After using a donated, 25 year old kiln, the art teachers were thrilled to receive the money to purchase the new kiln. The kiln will benefit over 400 students enrolled in various art offerings at the high school.

A new enthusiastic Fine Arts composed of both music and art teachers is already diligently working on a much more comprehensive grant proposal for this coming year for 08/09.



DesksonParade

A new Public Art Project is being organized by the District 300 Foundation and underwritten by a variety of individual and corporate sponsors. Local artists are invited to submit proposals that demonstrate their imagination and artistic talent to transform a 1960's circa school desk into a work of art. Proposals will be juried and the winning artists will be given a desk to paint or resurface.

Completed desks will be displayed in the community next spring and auctioned off online till April 30th. Money raised will support the Foundation's Grant Program which redirects the funds to local schools.

Innovation Grants

The Foundation funded a third round of Innovation Grants, up to \$500 for projects that could serve as pilot programs for Foundation or District expansion.
